Branches and Regional Committees are reminded that the closing date for submissions of Rules Proposals to the Special Rules Revision Conference 2025 is 09.00 Wednesday 4th June 2025. Submission of Rules Proposals can be posted or emailed but must arrive by 09.00.

If sending Proposals by post, Branches must ensure they use a signed for service which guarantees delivery by the closing date and time.

Branches, Regions, and the NEC are reminded that the Standing Orders Committee will not alter or amend any of the Rule Proposals submitted therefore it is important that

proposal authors read the attached guidance notes carefully and Rule Proposals are checked before they are submitted.

GENERAL GUIDANCE ON THE SUBMISSION OF PROPOSALS TO SPECIAL RULES REVISION CONFERENCE 2025

- a) Proposals may be submitted by email only using the appropriate templates and sent to conferences@cwu.org
- b) Proposals will only be accepted via the email address registered for the Branch at head office.
- c) All Proposals must be submitted to conferences@cwu.org and titled "Special Rules Revision Conference 2025".
- d) Proposals will not be admitted if sent to any other head office email address.
- e) Head Office will acknowledge receipt, of <u>all correspondence.</u> Acknowledgements will usually be sent within 72 hours.
- f) Should an acknowledgement not be received within this period, branches should contact Angela Niven at head office on 020 8971 7256.
- g) Branches who do not have email facilities should contact Angela Niven at head office to request forms.
- h) The SOC may seek validity of a Proposal submitted electronically by the examination of minute books of branch meetings.
- i) As this is a Special Rules Revision Conference only the following rules are open to amending Rule 7, Rule 8, Rule 9 and Rule 10.
- j) No proposals to alter/add to or delete any other Rules will be admitted to the agenda.

k) Branch and Regional Committees will be entitled to submit up to Two proposals to the Special Rules Revision Conference 2025.

Compositing of Rule Proposals to Special Rules Revision Conference 2025

j) The General Conference SOC may composite two or more rule proposals that seek to establish similar policy.

- k) All sections of the rule amendment form must be completed and must clearly state which Branch/Regional Committee is submitting the rule proposal.
- I) Rule proposals can be submitted electronically or by post but must be received at Head Office by 09.00 **on Wednesday 4**th **June 2025**
- m) If sending Motions by post, Branches must ensure they use a signed for service which guarantees delivery by the closing date and time.
- n) Branches, Regions and the Advisory Committee are reminded that the Standing Orders Committee will not alter or amend any of the proposals submitted therefore it is important that proposal authors read the guidance notes carefully and proposals are checked before they are submitted.
