FIGHTING FOR RESPECT

ince the last edition of the Veteran, the government's campaign against retired people and pensioners has clearly increased.

So too has our efforts to reinstate the Winter Fuel Allowance and secure justice for the WASPI women - two causes that have received wide support from across the union.

But despite this, it is quite clear that Labour in power has no intention of reversing their decisions at this stage, and may go further - indeed, if media speculation is correct, the long-term future of the triple lock might also be under threat.

Hardly a week passes by without a thinktank or politician speculating about the cost of the State Pension appearing in the media, with even the future of the Freedom Pass receiving some press attention.

Following a discussion at our national executive, the CWU has made a donation to the WASPI campaign and we have invited them to address the national executive's

next meeting, to which they have agreed.

And although our union and a small number of MPs have been abundantly clear on where they stand on this issue, the relative silence from the wider movement and the TUC has been very disappointing.

It seems clear to me that pensioners and retired people are seen as an easy target for politicians and economists who have blamed what they call 'boomers' for everything from the housing shortage to hospital 'bed blocking'.

If we intend to defend ourselves from these attacks, we need to up our game. The tools at our disposal are limited but start with convincing the wider trade union movement to support us.

More pressure must be put on MPs from all parties to let them know we won't be supporting any MP who doesn't support us.

We also need to convince younger workers that decent state pensions are in their interest, and where possible we should be linking this to their campaigns for decent housing, student debt, better occupational pensions and all issues affecting workers.

I would welcome ideas from members on how we can improve our tactics and invite readers to write in with any ideas they have.

We should never forget that we have paid billions of pounds into the exchequer, in terms of income tax and national insurance, during our working lives.

We are entitled to a decent state pension, care in retirement - and respect.

The hope of the elderly, the hope of the working class lies not in mealy mouthed repetitions of Labour leaders lying on an industrial scale.


It lies in the collective that is the trade union movement. It lies with a coming together of young and old to demand a better future for all.

LABOUR MPS MUST BACK WASPI WOMEN

After Keir Starmer has reneged on yet another promise by betraying women wronged by pension ages changes, MPs must be pressured to do what's right, writes WASPI chair Angela Madden...

ver the last 10 years, the Women Against State Pension Inequality – or WASPI -campaign has been fighting tooth and nail for justice on behalf of the 3.6 million women who weren't properly told about changes to their state pension age.

In the process of equalising state pension age through the 1995 and 2011 Pension Acts - of which we have no issue - the Department for Work and Pensions failed to notify women born in the 1950s that they would no longer retire at 60.

Some women found out only 18 months before their 60th birthday that their retirement date had been pushed back six years, leaving them little to no time to make alternative plans.

When the Parliamentary Ombudsman vindicated the campaign in March 2024, ordering ministers to apologise and urgently pay compensation, we had the justice almost in the palm of our hand.

With the support of hundreds of Labour MPs in opposition and throughout the general election, we were hopeful that the promises made to us would come to fruition following Labour's landslide victory.

However, on 17th December, giving under an hour's notice to their own MPs, ministers announced that while they accept the Ombudsman's findings of

maladministration and apologised for not properly informing 1950s women, there would be no compensation.

We recognise the country's difficult financial circumstances. But ignoring your own watchdog - who says the system got things wrong - is not the Labour many of us voted for. We'd expect this from Boris Johnson, not Sir Keir Starmer KC.

It seemed Labour took a political gamble, thinking WASPI women would simply go away while the issue would trickle to the bottom of the Order Paper. They were wrong.

The outrage from opposition parties and Labour's own MPs, both publicly and privately, has shown the strength of feeling on this injustice across the country.

As the Ombudsman made the highly unusual decision to lay the report before Parliament, he put justice in the hands of all 650 MPs, not just the government. With clear discontent from hundreds of our elected representatives, 3.6 million women and our supporters, it's only right there is a vote on compensation in government time.

retired from Royal Mail 11 years ago. Before then I served as a rep at every level of the Union from local to National Executive. So, when people ask me if I'm active in the retired members' committee and I reply "not really", it raises a few eyebrows.

The retired members' committees do a lot of good work. They campaign on issues affecting older people and keep their members in touch with each other. But that wasn't what I wanted to do when I retired. I saw myself still being active in three particular areas.

Helping bring forward and mentoring new and young workplace reps. In my over 50 years in the union I've learnt a lot, mostly from the many mistakes I've made - why not pass on that experience to new people so that they don't make the same ones and give them the confidence to become leaders in their workplace?

Helping the union recruit members in non-core industries. By necessity, recruitment in these areas starts from outside the workplace.

Our existing reps find it difficult to get time off to do this. But that's not a problem for retired members. We're used to talking to people and explaining why they need a union. We used to do it all the time. Helping the union to campaign on social and political issues. What happens outside the workplace affects our members and, quite rightly, the union takes a view on these and campaigns on them.

But after a hard day at work, most members feel they don't have the time or energy to take part. Us retired members don't have that holding us back anymore. And many of us have decades of experience campaigning on these issues.

Retired members have two valuable features to give the union. Time and experience. In the areas mentioned above and probably in many others, we could offer so much more if only someone would ask us.

But no one ever does. Instead, we're shuffled off to one side to deal with "retired" issues. In the discussions on restructuring, please look at how you could use us in a more effective way. If you do, it'll reap dividends. If you don't, then to quote the late Ian Dury, "What a Waste".
